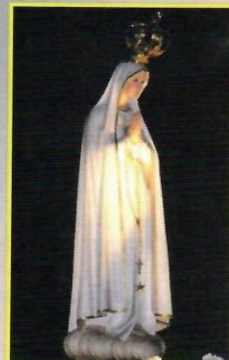

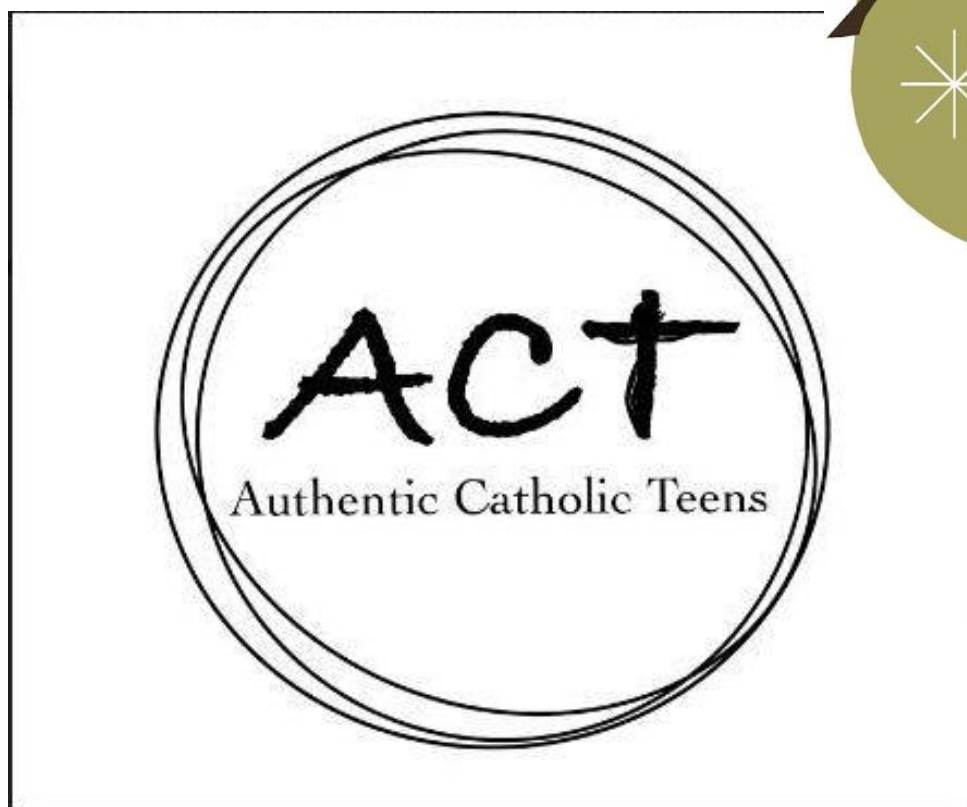
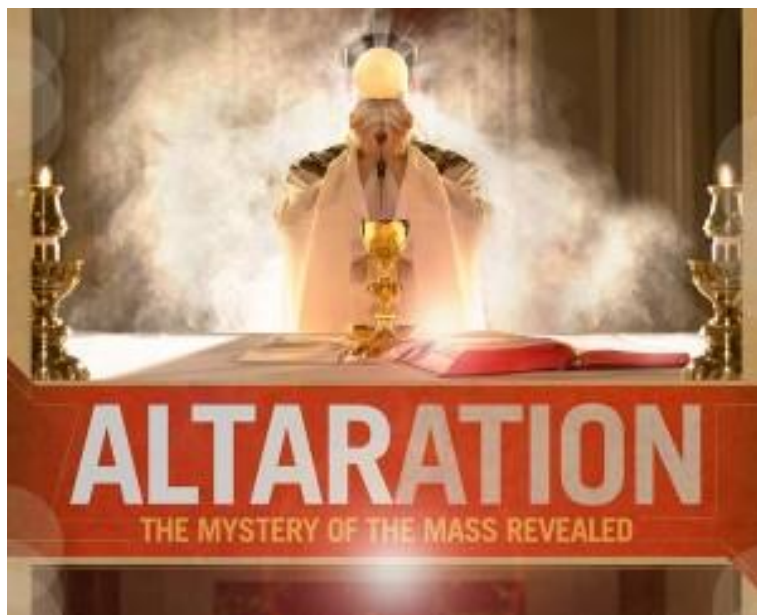
Faith Formation Registration
