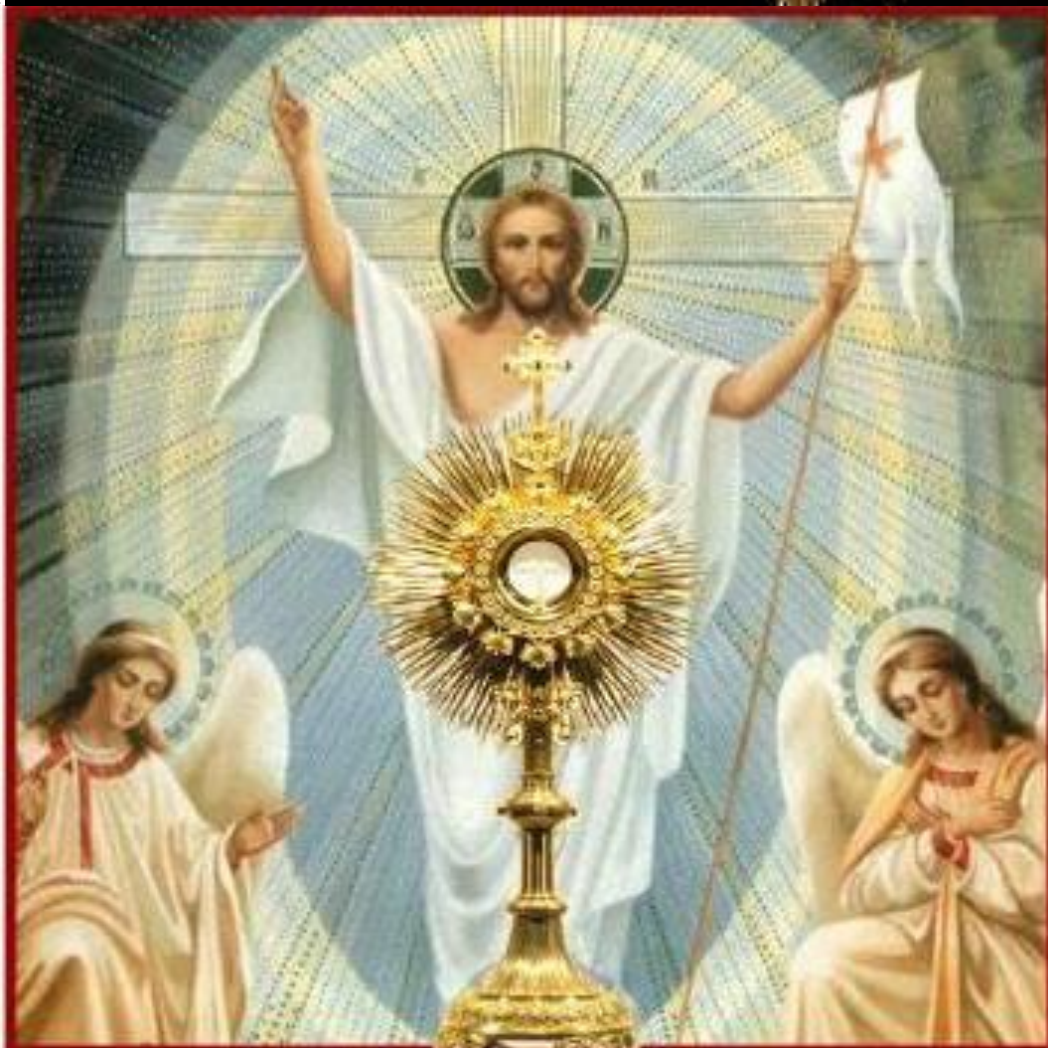

Diocesan 25th & 50th Wedding Anniversary Celebration

The St. Gianna Baby Pantry

This pantry offers clothing, formula, diapers, and other basic baby supplies to families. Baby items provided are based on the donations received from the community. On just one day in July 385 diapers, 16 packages of wipes, and 9 containers of formula, as well as clothes, blankets, crib sheets, lotion, baby wash, shampoo, were distributed. The need is so great that additional appointment times have been added. Your help is needed to help assure that the necessary supplies are not depleted. They are in need of diapers (Sizes: 4, 5, 6), Pull-Ups (any size), baby wipes, baby wash, formula, blankets (receiving and crib-size), and new or gently used story and picture books. Donate your gently used baby items Monday, Wednesday, or Friday from 1:00 to 4:00 pm at the Bessette Center in the Catholic Charities Warehouse or Monday-Friday from 8:30 am-4:30 pm at the Spalding Pastoral Center (419 NE Madison Avenue, Peoria).

NOTE: St. Joseph's SoA includes a one-time memorial gift of \$52,000 from the estate of a deceased parishioner and this extraordinary revenue is causing a surplus of \$37,683.66.
