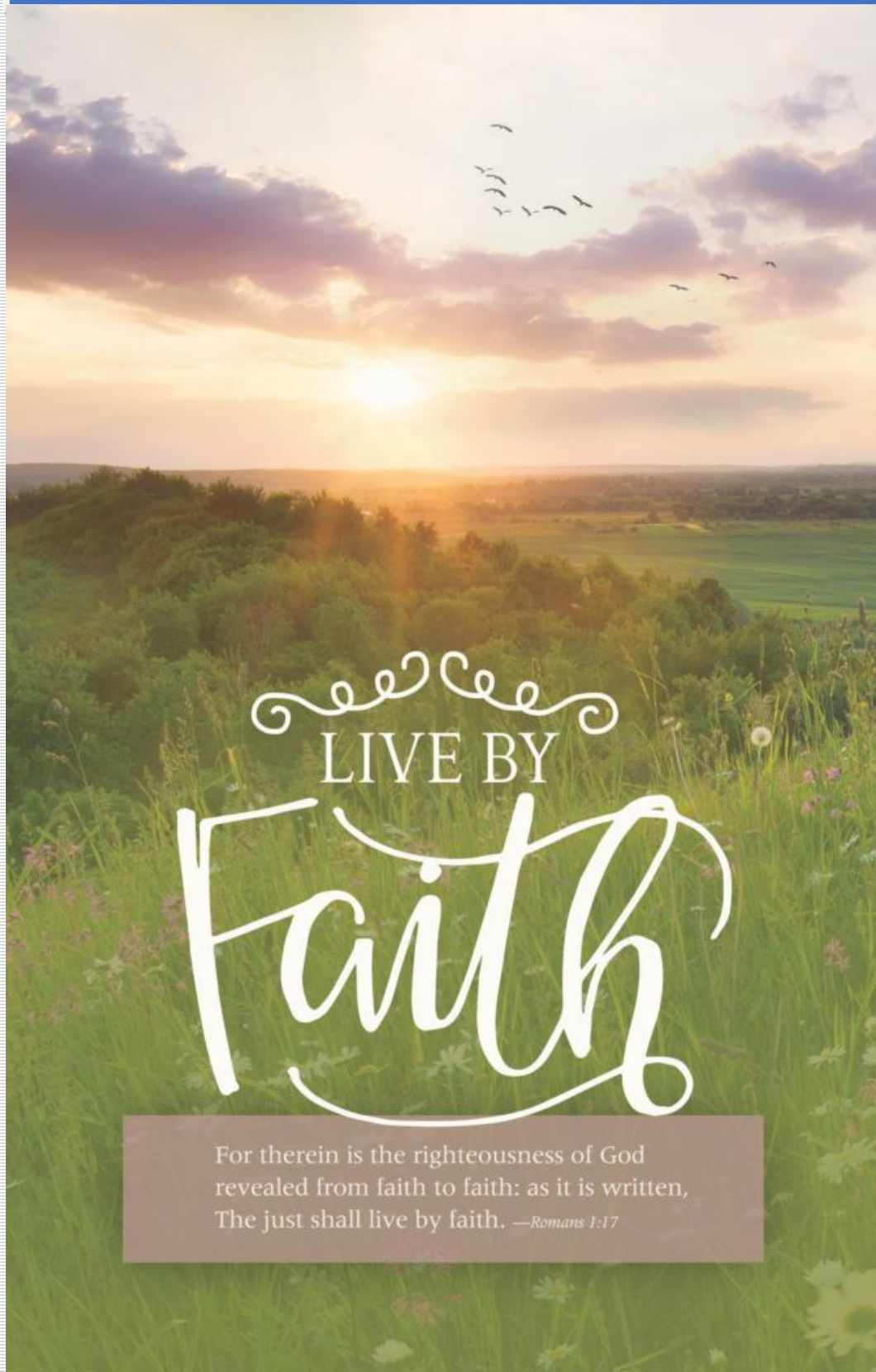

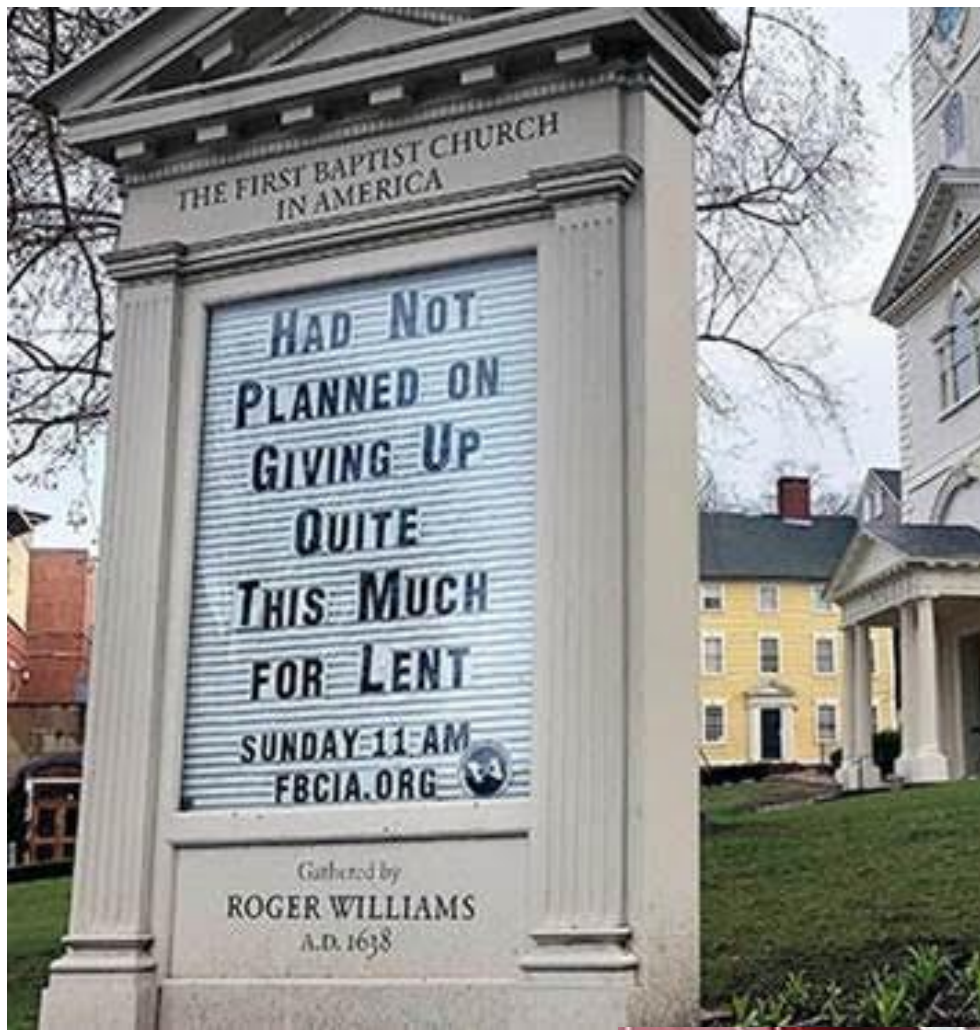
### ***Bishop Jenky has made a couple of changes to the 2020 ADA DRIVE***

- He has reduced our goals by 11% for this year because of Covid-19 closures
  - a. Believe St. Luke goal will be reduced to **\$20,581**
  - b. Believe St. Joseph's goal will be reduced to **\$10,065**
