MASKS AND PERSONAL PROTECTIVE EQUIPMENT (PPE)

- ✓ All individuals in school buildings or parish halls for Faith Formation (CCD) classes (students, catechists, and parish employees) are to wear masks.
- ✓ Families are asked to supply masks for their child/children. Reusable cloth masks are allowed with the stipulation that they be washed before coming to CCD if using the same mask.
- ✓ Disposable masks are preferred in class setting with the intention of disposing at the end of every class. Parents should send students with extra PPE in case masks are damaged during the day.
- ✓ Masks should not contain messages or images that would distract from the spiritual formation of the class.
- ✓ Parents will ensure the supply of PPE (disposable face masks, cleaning supplies such as alcohol gel) for their children.
- ✓ The parish will maintain a regular supply for cleaning surfaces before and after classes.

ARRIVAL PROCEDURES – WELLNESS CHECKS

- ✓ Whenever possible, students and catechists will utilize as many exterior doors as possible in the building to avoid congestion when entering or departing the building.
- ✓ All students and catechists shall wear a mask when entering the building at the beginning of classes.
- ✓ Catechists are responsible for taking their temperature every day. Any catechist or volunteer staff member with a temperature over 100.4 degrees Fahrenheit will be sent home.
- ✓ CCD directors will perform “wellness checks” of all students. A person should be assigned to temperature scan each student upon arrival, and any student with a temperature over 100.4 degrees Fahrenheit will be sent home.
- ✓ Students shall wash hands or receive hand sanitizer upon entering to CCD class to assist with safety and hygiene.
- ✓ Parents and guardians should not enter the building to escort students to/from classrooms at arrival and dismissal.

INFECTION PROTOCOL-WHAT TO DO IF SOMEONE GETS SICK

DEFINITION OF EXPOSURE TO COVID-19

To be considered exposed to COVID-19, you need to have prolonged close contact with a person who has the virus. **Close contact includes** living in the same household, caring for a sick person with the virus, being within 6 feet of a sick person with the virus for at least 15 continuous minutes without the use of a face covering, or being in direct contact with secretions from the sick person.

PREVENTION

As outlined in the *Health and Safety* section, temperature checks of all students and catechists will be taken on arrival. Any student, catechist or volunteer who has a temperature above 100.4 degrees Fahrenheit will be sent home and encouraged to contact a doctor.

RESPONSE TO COVID-19 SYMPTOMS

Contact: Person is without symptoms but has been made aware a COVID exposure has occurred (family, community, work).

- ✓ Get tested at least 5 days after the exposure. *Testing done prior to 5 days from the exposure may be falsely negative due to insufficient viral reproduction time.*
- ✓ May continue to go to class while awaiting results and wearing a mask, social distancing, and hand washing.
- ✓ Check temperature and symptoms twice a day. Any symptoms should be reported, and quarantine begins immediately until test results are returned.
- ✓ Family must be contacted if symptoms happen during CCD and DRE must be contacted if symptoms occur after coming to class.

Symptomatic:

- ✓ Anyone who is symptomatic for COVID (with or without) known exposure will be sent home immediately.
- ✓ Should also go for PCR nasal testing immediately. *Return to class will be guided by test results and CDC criteria.*
- ✓ Symptoms for COVID include: fever of 100.4 degrees, loss of taste/smell, fatigue/achy muscles, sinus/nasal, sore throat, nausea/vomiting/diarrhea, cough, shortness of breath.

- ✓ It is recommended that student's parents or employee contact their pediatrician or doctor to discuss the symptoms and arrange for an evaluation.
- ✓ Quarantine (no work/school) until: COVID negative or an alternate diagnosis is made (ear infection, strep, flu, etc.)
- ✓ If the pediatrician or doctor feels that an alternate diagnosis is confirmed or likely, the student or catechist can return with a physician/APN/PA note AND cessation of symptoms for at least 24 hours without fever reducing medication (Acetaminophen and Ibuprofen).
- ✓ If the student or catechist does not seek medical evaluation, does not receive COVID testing, or no alternate diagnosis is discovered, they should be considered a presumptive COVID positive case and shall remain out of class for 10 days from the on-set of symptoms PLUS at least 24 hours from resolution of fever reducing medication (Acetaminophen and Ibuprofen).
- ✓ No need to notify the parish and Diocese unless COVID test is positive.

COVID19 Positive:

- ✓ Quarantine minimum 10 days with 24 hours from resolution of fever-reducing medication (Acetaminophen and Ibuprofen).
- ✓ Even if not symptomatic, quarantine.
- ✓ Any confirmed case of COVID19 within the CCD will lead to notification of DRE and the /Director of Faith Formation of the Diocese, who will examine the pertinent exposure in order that monitoring can begin.

SHARING BUILDING SPACE WITH THE PARISH SCHOOL

- ✓ Parish ministries (such as Religious Education classes) and "external groups" (e.g., Boy Scouts, Girl Scouts, etc.) will be asked to use any vacant or unused instructional space. The pastor/chaplain and principal shall grant access to these required areas with the stipulation that the areas are thoroughly sanitized and disinfected before and after usage by the external groups.

From the Pastor:

- ✓ **"While these protocols were designed entirely by Diocesan officials, in conjunction with state and local governments, we will adopt them as our protocols for any and all church activities that take place at our facilities until further notice. Rosary groups, Moms' Wrap, Adult Education classes, Red Cross Blood Drives, etc. can now resume use of the church provided that they follow the above stated protocols and clean the church before and after each use.**
- ✓ **Any group that does not have a current member of the cleaning group in their group will have to contact Deacon Terry and Ashley Mahaffey for St. Luke's and Deacon Michael and Lucie Canamore for St. Josephs for the proper training and cleaning procedures"**

Beginning the weekend of August 15-16, we will be returning to the Pre-Covid Mass schedule which is Saturday at 4:00pm at St. Luke's and 5:30pm at St. Josephs until further notice. Sunday times will be 8:00am at St. Luke's and 10:00am at St. Josephs. Both days' Masses will have the option of **IN-HOUSE** and **DRIVE-UP**.
